Refer a Friend Program Terms & Conditions

1. General Terms

The "Refer a Friend" program ("Program") is organized and conducted by INVESTAiN, a non-dealing online foreign exchange broker, Financial Services Commission (FSC) of Mauritius, holding License No: GB24202963 hereinafter referred to as the "Promoter". As a Global Business License (GBL)/Category 1 Investment Dealer (Full-Service Dealer, excluding underwriting), we strictly comply with the Securities Act 2005, Securities Rules 2007, and Financial Services Rules 2008, ensuring adherence to high standards of operation and client protection. INVESTAiN 's principal office is located on the Ground Floor, Ebene House, 33 Hotel Avenue Cybercity, Ebene, 72201, Mauritius.

By participating in this Program, participants agree to be bound by these Terms and Conditions, which may be amended by the Promoter at any time with or without notice.

2. Eligibility of Referrer

To be eligible as a Referrer, you must:

- Be an existing, approved client of [Brand Name] with an active trading account.
- Not be an Introducing Broker (IB) with [Brand Name] or INVESTAiN.

3. Eligibility of Qualified Referred Client

Eligible Referrers will receive a cash bonus of \$15 USD for each Qualified Referred Client. A referred client is qualified when the following criteria are met:

- a. The referred client must be a new client who has never registered or applied for a live trading account with [Brand Name]. [Brand Name] reserves the right to determine if an applicant is a genuine new client by assessing whether they are associated with or related to any existing account holders.
- b. The referred client must register with [Brand Name] using the Referrer's unique referral code.
- c. The referred client's cumulative deposits must be equal to or exceed \$100 USD.
- d. The referred client must complete a minimum trading volume of \$400,000 USD Notional in Forex products.

4. Receiving the Bonus

The \$15 USD bonus will be credited to both the Referrer's and the Referred Client's trading accounts once the deposit and trading volume requirements are met, but no later than 24 business hours thereafter.

Each Referrer is eligible to receive the \$15 USD bonus only once per Qualified Referred Client. Likewise, each Referred Client can receive the bonus only once as a referred client. The bonus cannot be transferred to other individuals, account holders, or accounts.

5. Miscellaneous

The Promoter reserves the right to modify, change, or cancel this Program at any time without prior notice.

If the Promoter suspects that a participant has misused or attempted to misuse the Program or has acted in bad faith, it reserves the right to deny, withhold, or cancel the bonus. The Promoter may also terminate the participant's access to the services or block their account if necessary.

Trading in Forex and CFDs involves significant risk.

Participants should only engage in trading if they fully understand the risks involved. Participation in this Program should not be a driving factor for engaging in Forex or CFD trading.

The Promoter does not guarantee any profits from client trading activities. The Promoter shall not be held liable for any losses incurred by participants on their trading accounts.
